Sealed quotations/tenders process in Collector Puri Vide Letter No.3269/SW Date.01.10.2024 are invited from interest reputed Travel Agencies/tour operators or individuals for providing one (01) no o Diesel Driven Hiring Vehicle having capacity of maximum 07(seven sitting members including driver) which shall confirm the terms and conditions for official use in ICDS Project, Satyabadi on monthly rent basis which shall reach in this office through registered post or by person (dropped in the sealed quotation in this office) by Dt. 08.11.2024 till Dt.22.11.2024 at 4:00PM. All participants are directed to remain present or depute his/her representative on 25.11.2024 at 4:00PM at Sub-Collector, Puri Cum-chairman ICDS, Project Satyabadi for opening of tender.

1. The Vehicle must be in road worthy condition and shall not be more than 3 years from the date of its purchase and as on the date of publication of this tender notice along with registration certificate/ Vehicles Insurance paper, pollution control certificate/ Rode Permit/proof of up-to-date tax paid etc which are mandatory for paying the hiring charges.
2. The bidder has to deposit an amount of Rs.5000/- in shape of bank draft as EMD to participate in tender which shall be duly pledged in favour of CDPO, Satyabadi and the said draft will be converted as security in case of selected. The EMD of other unsuccessful bidder will be returned within 8 days. All bidders are required to attend the tender committee meeting or may depute any authorised person to attend which shall be intimated later.
3. Private vehicles may also be allowed to participate in the tender process with a condition that, if the Vehicle is selected, then the owner /bidder of the vehicle shall convert it to commercial taxi within seven days from the receipt of the order to ply the vehicle from the office of CDPO, Satyabadi failing which the EMD deposited by the bidder will be forfeited and next lowestillegible vehicle will be permitted for the same under approval of the competent authority.
4. The driver of the vehicle should be engaged by the owner who must be well behaved and obedient in nature and the salary of driver shall be borne by the owner.
5. The Driver of the vehicle must have a valid Driving licence and should have experience to drive transport commercial vehicles.
6. The monthly rate of hire charges is Rs27000/- excluding fuel and lubricants.
7. The vehicle must achieve a fuel efficiency of 10Kms per litre.
8. A copy of the Registration Certificate and copy of the Diving Licence duly signed by the concerned must be submitted along with the bid document for perusal of the committee.

10. The committee will deserve the right to cancel any of the bidding document in case of deficiency.
