



- OEM / Bidder must have a registered office in ODISHA to provide after sales service support. Proof copy must be enclosed.
- Escalation Matrix for Service Support: Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- Bidder has to submit original offer product Specification catalogue / literature / Data sheet duly signed by the OEM as compliance for inverter only.
- Bidders are advised to ensure compatibility of their product before quoting. An undertaking on bidder's letter head to this matter is compulsory.
- In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.
- Offer price to include all costs of components delivery at location (List enclosed) with Good Condition and Standard Installation. After successful installation the bidder must submit installation/completion certificate along with relevant documents.
- OEM/Bidder must submit the notary affidavit regarding non-blacklisted from any Govt Organization, PSU in Non-Judicial Stamp Paper mentioning Bid number and date.
- Maximum ceiling price of Sine Wave Inverter (As per Specification enclosed) – Rs.40,000/-

The District Education Officer-cum-DPC, Samagra Shiksha, Puri invites bids from the reputed & credible firms/ agencies for supply & installation of ***“Inverter, SSD Drive, RAM and provision of External HDDs for Desktop and Web Camera with microphone and speaker for Desktop”*** at 186 nos. of Cluster Resource Centers of Puri District (**List Annexed**). The detailed terms & conditions of the above bid are as under;

### **SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS**

1. **Eligibility Criteria:**

The firms/agencies must have:

- (a) Office set up in the State of Odisha
- (b) Valid PAN
- (c) Valid GST Registration under Odisha GST (OGST) Act.
- (d) Aadhar Number of the Proprietor

2. **Application Procedure:**

- (a) The Bid has been invited under two bid system i.e. **Technical Bid and Financial Bid**. The interested bidders are advised to submit two separate sealed envelopes superscribed **“Technical Bid for Upgradation of Desktop and supply of allied accessories & Inverter”** & **“Financial Bid for Upgradation of Desktop and supply of allied accessories & Inverter”**. Both sealed envelopes should be kept in another sealed envelope superscribed **“Tender for Upgradation of Desktop and supply of allied accessories & Inverter to CRC Point”**.

- (b) **Technical Bid & Financial Bid**

The Bidder has to fill up the Technical bid Form (**Tech-1, Tech-2, Tech-3 & Tech-04**) & submit it with a separate envelope with all self-attested documents/papers as mentioned in para-2 (f). Similarly, the Financial Bid form has to be filled up as per prescribed form (**Fin-1 & Fin-2**) and to be submitted in separate sealed envelope. The bidder is to quote **rate separately** in the prescribed format (**FIN-2**). All other charges, levies, duties, transportation cost, delivery & installation charges of the equipment to the cluster point (**As per list**).

- (e) **Earnest Money Deposit (EMD):** The bidder is to submit EMD amounting **as mentioned in the Table (Information to the Bidder)**. The EMD (refundable - without interest) may be submitted in shape of Demand Draft from any Nationalized or scheduled bank drawn in favour of **“District Project Coordinator, Samagra Shiksha, Puri”** Payable at Puri failing which the tender shall be rejected summarily. The instrument in original should be necessarily accompanied with the Technical Bid. The EMD of the un-successful bidders shall be refunded within 30 days after award of contract. The EMD shall be forfeited in the event of withdrawal of the tender once submitted or in case of a successful bidder who (i) fails to execute the agreement within specified period & (ii) not submitted performance security and/or express its inability to supply the finished material within the stipulated period. The EMD of successful bidder shall be refunded after receipt of Performance security.

4. **Submission & Opening of Tender:**

  - (b) **Late Bidders:** Any bid received by the authority after the prescribed time and dateline for submission of bids will not be considered and opened. Thus, the same is deemed to be rejected.

- (a) The District Level Technical Committee (DLTC) of the District Project Office will evaluate the Technical & Financial BID. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be opened.
- (b) The technically qualified bidder quoting lowest price in the Financial bid shall be considered for award of contract.

**7. Acceptance or Rejection of the Bids:**

- (a) The Tender Inviting Authority (TIA) reserves the right to accept / reject any / all bids / cancel the entire selection process at any stage without assigning any reason thereof. No claim, whatsoever, shall be admissible for the alleged loss/damage suffered by the bidder/s on account of such rejections.
- (b) Any bid with incomplete information is liable for rejection.

**8. Award of Contract:**

The contract will be awarded to the Bidder/s substantially responsive to the Bid document & offered lowest evaluated cost.

**9. Signing of Contract:**

- (a) The successful bidder/s whose bid has been accepted will sign an agreement with the TIA within 7 days of issue of the work order.
- (b) Failure by the tenderer to comply with the requirement of above mentioned clauses, the offer shall be rejected and the tenderer shall have no claim further.

**10. Performance Security Deposit:**

The selected bidder shall have to submit **Performance Security Deposit of 5% of contract value** in shape of bank draft drawn on any Nationalized / Scheduled Bank in favour of the “**District Project Coordinator, Samagra Shiksha, Puri**” payable at Puri only within 7 days from issue of the work order.

**11. Pre Delivery Inspection (PDI) & Post Delivery Inspection (PDI):**

The TIA shall do the Pre-Delivery Inspection (PDI) before supply and installation of materials to the Cluster Point for quality assurance purpose and after delivery and installation, the District Level Committee will make Post Delivery Inspection (PDI) before release of payment.

**12. Requirement & Delivery Schedule:**

The selected firm shall supply and install the “**Inverter, SSD Drive, RAM and provision of External HDDs for Desktop and Web Camera with microphone and speaker for Desktop**” within 30 days from the date of issue of the work order at 186 Cluster points.

**13. Payment terms:**

- (i) **On completion of delivery & installation at Cluster point**, 60% cost of total purchase value shall be paid within 30 days after receipt of the required reports / Papers/documents as under:
  - a. Cluster wise Challans towards supply, delivery, installation of required quantity to concerned cluster point as per supply order.
  - b. Receipt of Installation Report as per format enclosed duly signed by Cluster Resource Center Coordinator, MIS-cum-Planning Coordinator, ABEO-cum-BRCC and Block Education Officer concerned.

- c. On fulfillment of conditions of the agreement.
  - d. Three self-inking carbon copies of the GSTIN invoice as well as bank details for payment purpose.
- (ii) **On Final Acceptance:** Rest 40% cost of the total supplied quantity shall be paid after deduction of penalty, if any, within 30 days of:
- a. Receipt & outcome of Post Delivery Inspection (PDI) Report.
  - b. On fulfillment of conditions of the agreement
  - c. Three self-inking carbon copies of the GSTIN invoice as well as bank details for payment purpose.
- (iii) No advance payment shall be made, or no part payment shall be entertained on negotiation.
- (iv) Deduction of tax at source shall be made at the appropriate rate as per prevailing law.

**14. Penalty:**

- (a) If the work is delayed for any reason for which the TIA is not responsible, penalty @ 0.5 % per week or part thereof on the total cost maximum up to 10% of the contract value will be imposed on the firm under orders of appropriate Authority. The TIA reserves the right to forfeit the Performance Security & debar the bidder from participating in any other bid of his/her office. In such cases the TIA may write Govt. for blacklisting the firm.
- (b) If the Post Delivery Inspection of the quality & quantity of devices and warranty period of devices supplied is not adequate at per with the specification or Higher, terms and condition laid down in the Bid Document and agreement, then penalty will be imposed proportionately on the total cost after deduction of tolerance limit prescribed by Govt., if any.
- (c) If the quality & quantity of devices and warranty period of devices supplied is found to be dissatisfactory, penalty as suggested by the Competent Authority will be imposed.

15. **Amendments to BID terms, conditions and issue of Corrigendum/ addendum:**
- (a) Five (05) days before the last date of submission of Bids, the TIA may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder/s, modify the Bidding Documents by amendment/ corrigendum.
  - (b) The amendment in shape of corrigendum/ addendum will be notified on the websites [puri.odisha.gov.in/](http://puri.odisha.gov.in/) [osepa.odisha.gov.in](http://osepa.odisha.gov.in) and the prospective bidder/s are requested to take cognizance of such notification/s while submitting their tender proposal.
  - (c) In order to allow prospective Bidder/s reasonable time in which to take the amendment into account in preparing their bid, the TIA may, at its discretion, extend the deadline for the submission of bids.
