Sealed quotations/ tenders are invited from interested reputed Travel Agencies/ Tour Operators or private individuals for providing one (01) no. of Non AC/ AC Diesel driven vehicles having seven sitting capacity including Driver, which shall confirm to the Terms and Conditions (Annexure-II) for official use in I.C.D.S Project, Krushnaprasad on monthly rent basis.

1. The vehicle must be in Road worthy condition shall not be more than 3 years from the date of purchase and as on the date of publication of the tender notice along with Registration Certificate/Vehicle Insurance Certificate, Pollution Control Certificate / Proof of up to date tax paid etc. which are mandatory for plying the hiring charges.
2. The Bidder has to deposit an amount of Rs.5000/-in shape of Bank Draft as EMD to participate in tender which shall be duly placed in favour of CDPO,Krushnaprasad and the said draft will be converted as security in case of selected. The EMD of other unsuccessful bidder will be returned within 8 days. All bidders are required to attend the tender committee meeting or may be depute any authorized person to attend which shall be intimated later.
3. Private Vehicles may also be allowed to participate in the tender process with condition that if the vehicle is selected, then the owner/bidder of the vehicle shall convert it to commercial taxi within seven days from the receipt of the order to ply the vehicle from the office of the CDPO,Krushnaprasad failing which the EMD deposited by the bidder will be forfeited and next lowest eligible vehicle will be permitted for the same under approval of the competent authority.
4. The Driver of the vehicle should be engaged by the owner who must be well behave and obedient in nature and the salary of the driver shall be borne by the owner.
5. The Driver of the vehicle must have a valid Driving License and should have experience to drive transport commercial vehicles.
6. The monthly rate of hire charges Rs.25000 excluding fuel and lubricants.
7. The vehicle must achieve a fuel efficiency of the 10 Kms. per litre.
8. A copy of the Registration Certificate and the copy of the Driving License duly signed by the concerned must be submitted along with the bid document for perusal of the committee.
9. The tender paper for the propose is available in the office which can be procured on payment Rs.100/-
10. The committee will deserve the right to cancel any of the bidding document in case of deficiency.
11. Other terms and conditions as per the requirement in the form shall be filled by the each bidder with the paper.


Terms and Condition for hiring of Vehicle.
