Sealed quotations/tenders are invited from interest reputed Travel Agencies/ tour operators or individuals for providing one (01) no o Diesel Driven Vehicle having capacity of maximum 07(seven sitting members including driver) which shall confirm the terms and conditions for official use in ICDS Project, Astaranga on monthly rent basis which shall reach in this office through registered post or by person (dropped in the sealed box retained in this office) by Dt; 07.01.2025 till 21.01.2025 at 4.30PM. All participants are directed to remain present or depute his/her representative on 22.01.2025 at 4.30 PM at office chamber of sub-collector puri, for opening of tender.

1. The Vehicle must be in road worthy condition and shall not be more than 3 years from the date of its purchase and as on the date of publication of this tender notice along with registration certificate/ Vehicles Insurance paper, pollution control certificate/ proof of up-to-date tax paid etc which are mandatory for paying the hiring charges.
2. The bidder has to deposit an amount of Rs.5000/- in shape of bank draft as EMD to participate in tender which shall be duly pledged in favour of CDPO, Astaranga and the said draft will be converted as security in case of selected. The EMD of other unsuccessful bidder will be returned within 8 days. All bidders are required to attend the tender committee meeting or may depute any authorised person to attend which shall be intimated later.
3. Private vehicles may also be allowed to participate in the tender process with a condition that, if the Vehicle is selected, then the owner / bidder of the vehicle shall convert it to commercial taxi within seven days from the receipt of the order to apply the vehicle from the office of CDPO, Astaranga failing which the EMD deposited by the bidder will be forfeited and next lowest illegible vehicle will be permitted for the same under approval of the competent authority.
4. The driver of the vehicle should be engaged by the owner who must be well behaved and obedient in nature and the salary of driver shall be borne by the owner.
5. The Driver of the vehicle must have a valid Driving licence and should have experience to drive transport commercial vehicles.
6. The monthly rate of hire charges is Rs.27000/- including fuel and lubricants.
7. The vehicle must achieve a fuel efficiency of 10k.m per litre.
8. A copy of the Registration Certificate and copy of the Diving Licence duly signed by the concerned must be submitted along with the bid document for perusal of the committee.

9. The Tender paper for the purpose is available in the office which can be procured on payment of Rs.100/-
10. The committee will deserve the right to cancel any of the bidding document in case of deficiency.
11. Other terms and conditions as per the requirement in the form shall be filled by each bidder with the paper.
