TERMS OF REFERENCE

General Terms and Conditions :

1. The firm should supply cooked food of good quality.
2. Out of the 1200 cooked food, 400 cooked foods on both the days should be packed in separate Aluminum foil by the approved firm for onward distribution to different First Aid Centres.
3. All the food packets should be supplied by the firm at the site of buffet i.e. Vehicle Stand, O/o-C.D.M.&P.H.O., Puri before 12 Noon on both the days.
4. All the food packets should be served by the personnel engaged by the approved firm.
5. The firm should have a valid Food License and GST No.
6. The EMD will be forfeited if the selected party fails to execute the assignment after being selected or fails to comply with work assigned in time, or any deviation is made from defined norms or specifications.

DOCUMENTS FOR TECHNICAL BID

The firm must submit the following documents in order to qualify in the technical bid.

1. Copy of GSTIN certificate.
2. Copy of Food License.
3. Demand Draft of **Rs.2000/- (Non refundable)** towards tender cost to be paid in favor of the **CDM & PHO and DPHO, Puri Car Festival-2024 A/C No-35881673575** from any nationalized Bank, payable at Puri. The DD must be given in original and put in the technical bid envelope. (Xerox copy will lead to rejection of Bid).
4. Demand Draft for an amount equals to 10% of the respective value of work awarded (exclusive of GST) is to be paid in favor of the **CDM & PHO and DPHO, Puri Car Festival-2024 A/C No-35881673575** from any nationalized Bank, payable at Puri. The DD must be given in original before the work order is issued in case of selected bidders only.
5. All the above documents must be kept inside the technical bid envelope. In case any of the documents is not found then the bidder will not qualify for opening of financial bid.
