The Bidding documents must be submitted with tender paper cost of rate Rs. 5,000/- (Rupees five thousand) only in shape of *Demand Draft* & to be drawn in any Nationalized Bank in favor of District Sports Officer, Puri otherwise the Bid will be rejected.

**Envelop-A (Technical Bid) [Documents to be submitted]**

1. The Quotationers must have an attested copy of valid GST Certificate of their respective Firms.
2. Self-attested photo copy of PAN Card and Aadhar Card.
3. The Total turnover must be of an amount more than Rs. 50.00 Lakhs of the tendering firm by last preceding 3 (three) financial years duly certified by a Chartered Accountant (CA).
4. The Quotationer is required to submit a self-declaration in an affidavit (as per *Annexure-I*) that he has not been *Black Listed* by any Govt. organization & he has gone through the tender documents carefully and shall accept all terms and conditions therein.
5. The basic details of the Applicant must be submitted on the Letter Head of the applicant (as per *Annexure-II*).

**Envelop-B (Financial Bid)**

1. The Quotationers are required to submit/present the sample of the Wrestling mat with cover along with cost before the Purchase Committee on the day of opening of Tender. Qualitative, branded and durable items shall be preferred and will be selected by the purchase committee only. Acceptable offer from *Envelope-A* should be opened for further evaluation and ranking before awarding the contract.
2. The quoted rate of the item should be inclusive of all taxes i.e. G.S.T & charges (for transportation) packing forwarding and freight etc.
3. The rate will be valid for the financial year 2025-26 from the date of approval.



**TERMS AND CONDITIONS OF SEALED TENDER CALL**  
**FOR SUPPLY OF WRESTLING MATS TO DISTRICT SPORTS OFFICE, PURI**  
**For The Financial Year 2025-26**

1. The Quotationers are to submit their tenders in sealed envelopes separately for *Technical Bid & Financial Bid* by super scribing Envelope 'A' (Technical Bid) & Envelope 'B' (Financial Bid) and both the covers shall be put into a third cover (Envelope 'C'), which should be super scribed as 'Tender for Supply of Wrestling Mat with cover to District Sports Office, Puri for the year 2025-26'.
2. The Financial Bid will be opened only of those bidders who have qualified in the Technical Bid & submitted the required documents as per the prescribed format with proper Signature & Seal.
3. The rate will be valid for the financial year 2025-26 from the date of approval.
4. The sealed quotation(s) will be submitted through Regd. Post/ Speed post/ Courier addressed to the District Sports Officer, Collectorate, Puri and the quotations must reach by **01:00 PM** on or before **15.07.2025**. The received tender papers will be opened at the office of the *Additional District Magistrate, Puri* by **04:00 PM** on **15.07.2025** in presence of Purchase Committee members & in presence of Authorized persons of concerned firms.
5. The incomplete quotations shall be rejected by the Purchase Committee without any reason thereof.
6. The applicable *Specification* of the Wrestling Mat must be of 70mm (in thickness) & 2mtr/1mtr (in length & breadth). The Full Mat Cover (for 72no. of Wrestling Mat) must be thick enough for long durability.
7. The samples of Wrestling Mat & Cover will be examined thoroughly by the Purchase Committee and their comments/recommendation will be considered as final. The qualitative, branded and durable items will be preferred first.
8. The purchase order shall be placed as per the actual requirement (72 no. of Wrestling Mat & Cover). Order shall be placed with the approved supplier. The selected quotationer should supply the materials to the District Sports Officer, Puri within 20 days (twenty days) from the date of issue of *Supply Order*, strictly as per the sample approved by the Purchase Committee. The delivery point details will be informed at the time of *Supply Order* by the District Sports Officer, Puri.
9. If the suppliers fail to supply the material within the stipulated time period and as per approved sample, the authority as rights to extend / cancelled the supply order.
10. The unsuccessful quotationers shall arrange to take back their samples at their own risk.
11. The authority reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
12. Dispute, if any, should be within Puri jurisdiction only.
