2	As per Sl. no. 21 of Annexure-II Details of Applicant,(Page no. 28) Average Annual Turnover for 2020-21,2021-22 & 2022-23, but as per Annexure IV the turnover of Last 3 FY i.e. 2021-22,2022-23 & 2023-24.	In Sl. no. 21 of Annexure-II Details of Applicant, (Page no. 28), Average Annual Turnover should be filled for FY 2021-22,2022-23 & 2023-24
3	That, in page no 11, clause no.05 of Financial eligibility in the last 3 financial years ending i.e. 31.03.2024. It should be changed ending i.e. 31.03.2025 (Provisional).	As Per RFP (No Revised/Addendum Clause of RFP is allowed)
4	That, in page no 11, clause no 5, the applicant should submit only one bid against each work, but it should be changed to submit one bid for all 5 works, because all are the same work.	As Per RFP (No Revised/Addendum Clause of RFP is allowed)
5	That, in page no 30, Annexure-IV Turnover for 2021-22, 2022-23 & 2023-24. But it should be changed for the last 3 years i.e. 2022-23, 2023-24 & 2024-25..	As Per RFP (No Revised/Addendum Clause of RFP is allowed)
6	That, in page no 33 clause no 8, you have mentioned that 240L bins are 20 nos., but the bins are 30L to 70L not more that. So it should be changed accordingly on all sites.	In page no 33 clause no 8, 240L Bin will be treated as 100L Bin
