EXPRESSION OF INTEREST (EOI) is hereby invited FOR SELECTION OF MSE (Micro & Small Enterprise) having MANUFACTURING UNITS & WSHG (Women Self-help groups) having TAILORING UNITS FOR PROCUREMENT AND SUPPLY OF SCHOOL UNIFORMS TO STUDENTS from class I to VIII of GOVT., SC & ST dept. & GOVT. AIDED ELEMENTARY SCHOOLS UNDER SAMAGRA SHIKSHA/PM SHRI / GANGADHAR MEHER SHIKSHA MANAKA BRUDHI YOJANA (GMSMBY), Puri district for the year.2025-26

Interested MSE with manufacturing units/WSHGs with tailoring units having willingness and aptitude for providing school uniforms to schools as above, may submit their proposal before the concerned Block Education Officer (BEO) in the format mentioned below within 14 days (fourteen days) of issue of this advertisement i.e. by 09.07.2025. MSE Manufacturing units/WSHGs units should preferably be from the same block/any of the adjoining Block under the Puri district as per the location of the schools where they propose to take up the activity through the given terms and conditions mentioned below. No proposals after last date will be received from any WSHG/MSE. Only MSE having manufacturing unit & WSHG having tailoring unit are eligible to apply.

TERMS AND CONDITIONS FOR PROCUREMENT AND SUPPLY OF SCHOOL UNIFORMS

1. Interested MSE/WSHG units of Puri district will apply in the prescribed format to the Block Education Officer in the above specified time period.
2. After receipt of application from MSE/WSHG units it will be verified/ short listed as per guideline by Block Level Committee (BLC) on the basis of proper field inspection without any favour or support to any group violating the guideline. **Recommendation will be submitted to the District Level Committee (DLC) by BLC for final approval by Collector-cum-Chairman, within 7 days of last date of advertisement .** BEOs will intimate immediately the selected list of approved WSHG/MSE by the DLC to the schools for follow up action.
3. MSE/WSHG units within the same block or adjoining block of Puri district will be tagged to the schools on the basis of their capacity of supplying in specified period.
4. The MSE Manufacturing units/WSHG tailoring units should supply the materials within the **timeline given** by the school from the date of issue of supply order failing which the supply **order will be cancelled.**

5. They may provide more than one sample uniform both for boys and girls, as per the specification & design. The best sample should be selected and kept in the school for checking and auditing purpose.
6. For boy's students of class, I to VIII, 2 pairs of navy blue colour half pant and white colour half shirt.
7. For girl's students of class I to V, 2 pairs of sky blue colour frocks (with Jhalery) & for class VI to VIII girls, 2 pairs of sky blue colour Kameez, 2 pairs of white colour Salwar & white colour Odhani (Dupata/ Chuni)
8. **Since the price of each item is fixed, so the best quality sample must be provided with exact cost of Rs.500/- & specification as specified shall be accepted from MSE/WSHG**
9. Rs. 500/- will be the rate for Two pairs of uniforms (inclusive of taxes, packing and transportation to school point).
10. All girls, SC, ST& BPL boys of Govt. schools will be provided dress @ 500/- from SAMAGRA SHIKSHA GRANT. All students of Govt. Aided Schools, APL boys of Govt. Schools & students of PM SHRI Schools will be provided 2 pairs of dress @500/- under State Grant, (Gangadhar Meher Shiksha Manaka Brudhi Jojana) & PM SHRI grant.
11. **In no case advance payment will be made for the materials so indented.** Payment to the supplier will be made through e-payment and no payment will be made in cash.
12. Any damage found in the supply of school uniforms is not liable to the intending authority. The MSE Manufacturing units/WSHG units will supply best quality school uniforms as per prescribed specification & sample given by the units during proposal submission/ agreement signature. School will give supply order to the units selected mentioning time line to supply. School can cancel supply order if the unit fails to supply in time & issue fresh order to any units in the Pannel. Before that selected units must be intimated that your unit fails to supply uniform in the given time line .
13. School authorities will check quality of the uniform as per sample provided while receiving it from the MSE units/WSHG units. Only best quality uniform will be received from MSE/WSHG as per samples given by the units.
14. The details of different qualities and brands should be mentioned in the Expression of Interest (EOI).
15. Quantity of materials to be processed may change as per actual requirement.
16. Expression of Interest received without fulfilling terms and conditions is liable for rejection.
- 17- The selected MSE/WSHG having manufacturing unit & tailoring units shall be valid for two years i; e 2025-26 &2026-27 to supply uniform to the same schools. However, any changes in this regard shall be intimated by the Govt. The Collector-cum- Chairman, SS, Puri
