The District Project Co-ordinator, Samagra Shiksha, Puri on behalf of Government of Odisha invites Percentage Rate bids in Single cover system only in "ON LINE" mode for the work as detailed in the table, from the class of eligible contractors as mentioned in column-8 (Eight) registered with the State Governments having validity of Civil License and Contractors of equivalent Grades /Class Registered with Central Government / MES / Railways and other state government having validity of Civil License for execution of Building Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under Odisha State Government has to register under the state PWD in appropriate class of eligibility before signing of the agreement. The bidder may submit the following works.

- The bidder shall have to transfer 'ON LINE' the Earnest Money Deposit/ Bid security and cost of bidding for the amount specified for the above work in the table, col. 4 & 5 above as part of bidding through a process as mentioned in the DTCN. Bidders desirous to hire machineries or equipment from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security.

4. The Bid documents will be available in the website (<https://tendersodisha.gov.in>) from 10:00 Hours of date- 21.11.2025 to 17.00 Hours of date- 11.12.2025 for online bidding.
5. The Bidder must possess Compatible Digital Signature Certificate (DSC).
6. Bids shall be received only in "On-line" on or before 17:00 Hours of date 11.12.2025.
7. Bids received "On-line" shall be opened at 11.00 A.M. on date 12.12.2025 in the office of the District Project Co-ordinator, Samagra Shiksha, Puri, Odisha in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The bidder shall transfer Online the cost of bid document as mentioned in the table above, towards cost of the bid through a process as mentioned under DTCN.
9. Detailed information as contained in the DTCN shall have to be strictly adhered to while submitting the tender papers.
10. Engineer Contractor desirous to avail the facility of exemption of EMD is required to submit an Affidavit in original to the effect that he has not yet availed the facility for more than three works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the Affidavit.
11. Any tenderer desirous to avail any facility as per certain circular/order of Government have to apply for the same in writing along with the tender paper. Claim at the time of opening of tender or later will not be entertained.
12. Other details can be seen in the bid documents.
13. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in on-line bidding.
14. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Code in practice will be taken against him /her.
15. If after opening of the tender it is seen that, the tender has to be decided through a transparent lottery system then the lottery date will be intimated through email, and speed post. The lottery will be held even if no bidder remains present.
16. The authority will not be held responsible for any technical problem / failure of Network, Server during the schedule dates of online bidding.
17. Conditional tender will be summarily rejected. The Department reserves the right to reject any or all bids without assigning any reason thereof.
18. Bidders shall provide their E-mail id, correspondence address, Mobile No. along with scan copy of valid GSTIN, PAN, Experience Certificate, Machinery documents and other documents as per DTCN Clause
19. Any corrigendum / Addendum will be displayed in the website (<https://tendersodisha.gov.in>) only.




