Expression of interest proposals are invited from the Registered Agencies/Individuals for supply of the Drugs & Consumables on discount basis.

The proposals should reach to the undersigned on or before **11.11.2025 11.A.M** and the same will be opened on dated **11.11.2025 at 12.00 NOON** in the office chamber of the C.D.M & P.H.O, Puri in presence of the tenderers or their authorized representatives. The authority reserves full rights to accept or reject any or all tenders without assigning any reason thereof.

Receipt of Tender

The sealed tender must be sent through Regd. Post/Speed Post/ Courier Services only.

Tender Cost

The bidders shall deposit / online transfer the tender processing fee (non-refundable) amounting to Rs.3,000/- in Punjab National Bank Account No. 3224000100071273 ; IFSC – PUNB0322400,Grand Road,Puri) and submit the copy of deposit challan / online transfer slip along with bid for verification.

E.M.D

- (i) The tenderer is required to submit the earnest money deposit amounting to Rs1,00,000.00 (One Lakh) only in shape of bank Guarantee pledged to C.D.M & P.HO,Puri.
- (ii) The E.M.D of the unsuccessful bidder will be returned only after finalization of the tender.
- (iii) The E.M.D of the successful bidder will be kept as performance security.
- (iv) The E.M.D will be forfeited if the successful bidder will refuse to supply the indented items.

Terms & Conditions

- (i) The bidders are to submit their tenders in separate sealed covered envelopes for technical bid & price bid by superscribing Cover 'A' (Technical Bid) & Cover 'B' (Price Bid) and both the covers should be put into a third cover , which should be superscribed as '**EXPRESSION OF INTEREST FOR SUPPLY OF DRUGS & MEDICAL CONSUMABLES ON DISCOUNT BASIS.**'
- (ii) Tenders shall be opened on due date and time as mentioned above in case the scheduled date is declared as Govt. holiday then such date shall automatically shifted to next working day.
- (iii) The price bid will be opened only those bidders who have qualified in the technical bid & should be submitted with signature & Seal.
- (iv) The approved discount will be valid up to one year from the date of approval subject to renewal annually after satisfaction not exceeding three years.
- (v) In case of any tender amendment and clarification, responsibility thereon lies with the tenderer to collect the same from the Web site before the last date of submission of tender & purchaser shall have no responsibility for any delay/omission on part of the tender.

- (vi) The bidder having experience for supply of materials to any Govt organisation may be given preference.
- (vii) No Price escalation will be entertained during the tenure.
- (viii) Bidder must have his own establishment, subletting is not allowed.
- (ix) The Local firm within a 200 meters radius from the D.H.H,Puri shall be given preference.
- (x) The approved firm should be able to supply the required medicines on 24 x 7 basis to meet any emergency situation.
- (xi) Highest discount proposal will be accepted (The discount should not be less than 22.3%)
- (xii) The indented /prescribed items should be supplied immediately to the patients & less MRP will be preferred.

Documents to be submitted with the Technical Bid

- (i) Xerox copy of Valid Drug License from the competent authority are to be attached in the tender proposal.
- (ii) The firm should have a valid GST registered firm, Xerox copy must be attached with the proposal, return statement of last 3 month/last quarter must be attached.
- (iii) Photograph of their establishment to be attached as a proof of the establishment and its location on satellite image or google map.
- (iv) The bidder is required to provide a self declaration in an affidavit (as per annexure -1) that he has not been black listed by any Govt. organisation & he has gone through the tender document carefully and shall accept all terms and conditions of the document.
- (v) Copy of Income tax return file for the previous three assessment year.
- (vi) The authority reserves full rights to accept or reject any or all tenders without assigning any reason thereof.
