Bidders or their authorised representative are desired to attend the bid opening process else the bid will be opened in their absence. Terms & Conditions:

1. Tender papers completed in all respect should reach in the office of the undersigned within the stipulated time through Speed Post/Registered Post only, super scribing "Tender for Poshan Sakhi kits" on the envelope cover.
2. Each bidder shall submit only one tender paper.
3. Tender shall remain valid for a period not less than 90 days after the deadline date specified for submission.
4. The Bidder must have registered under Goods & Services Tax (GST) and must have a valid GSTIN number & PAN (Permanent Account Number).
5. The price quoted should be inclusive of cost of material to be supplied per unit & should be inclusive of all taxes & charges, packing & transportation cost of delivery at Block OLM cell o/o of respective BDOs.

6. EMD of Rs 30000/- shall be paid by the bidder in shape of NSC/TD/FD duly pledge in favour of the “ Odisha Livelihoods Mission (NRLM),Puri “ payable at SBI,Main Branch, Puri. The EMD of the selected tenderer will be kept as security deposit and refunded only after completion of all transaction in this regard. In case of unsuccessful tenderer, the EMD will be returned after finalization of the tender. The EMD of Rs 30,000 is mandatory for all tenderers and it should be issued only after publication of this tender notice.
7. The selected bidders have to supply the items within 15 days from the date of issuance work order at respective Blocks.
8. The purchaser will award the contract to the bidder whose bid has been determined to be substantially responsive and has offered the lowest evaluated quotation price.
9. The Bid has been invited under two bid system i.e Technical Bid and Financial Bid. The interested bidders are advised to submit two separate sealed envelopes super scribing Technical Bid and Financial Bid and the sample submitted with tender paper. The committee will decide ,If price quoted by the bidder is same.
10. The tenderer has to apply in the prescribed format only. The tender applied in any other format is liable for rejection.
11. The technical bid of all tenderers will be opened first for evaluation by the tender committee. The price bid (Financial Bid) of successful tenderer in technical bid will be opened latter.
12. The original documents should be produced by the bidder for verification when asked for.
13. Violations of any clause by the bidder stated in tender call notice will amount to rejection of the tender papers.
14. Any legal dispute arising out of this is subject to Puri jurisdiction only.


