5. The Firms should have necessary expertise to complete the assignment within the stipulated time schedule.
6. The Sealed quotations/ tenders should be reached through Regd. Post / Insured Speed Post / by Hand shall be accepted **on or before 5.30 PM of dt. 11.02.2026** by this office and the same shall be opened on dt. **12.02.2026 at 03.30 PM in the office chamber of CDPO, Puri Municipality** in presence of Purchase Committee members and Bidders or his authorized representatives, if they so desire.
7. The quotations/tenders received in incomplete form or after the scheduled date & time shall be summarily rejected. The Purchase Committee reserves the right to reject all or any quotations/ tenders without assigning any reason thereof.
8. On delivery, the products shall be inspected to ascertain the specification of quality and quantity for which the order was placed. If, it turns out to be otherwise, the acceptance or delivery shall be refused and ask for explanation for supplying so.


